We would like to remind you that the Los Angeles County Fire Department requires a film permit for ALL film productions occurring within its jurisdiction, with the exception of "Certified Film Studios". Contract Cities within Los Angeles County Fire Department's jurisdiction which do not have a current Los Angeles County Film Permit, should access our website at fire.lacounty.gov under Fire Prevention, Film Unit Documents and Permits.

Film Permits will be issued from 8:00 am to 3:00 pm, Monday through Friday. In order to guarantee a Fire Safety Official for the next day, your permit must be turned in by 12:00 p.m. the previous day.

The Fire Department is continually assessing and evaluating our operations and business processes. These changes have been made to bring consistency and efficiency to our operations. It is our objective to provide the best customer service possible.
